#### Cabinet Resolution No. (132) of 2023

#### Concerning the Administrative Penalties against Violators of The Provisions of the Cabinet

#### Resolution No. (109) of 2023 Concerning the Regulation of Beneficial Owner Procedures

#### Abrogating:

Cabinet Decision No. 53/2021

#### The Cabinet

- Pursuant to the perusal of the Constitution;
- Cabinet Decision No. (109) of 2023 on regulating Beneficial Ownership Procedures;
- Cabinet Decision No. (53) of 2021 on the administrative fines to be imposed on the violators of Cabinet Decision No. (58) of 2020 concerning the regulation of Beneficial Ownership Procedures; and
- Based on the proposal of the Minister of Finance and the Minister of Economy, and the approval of the Council of Ministers,

#### Herby resolved:

#### Article 1

#### Definitions

In implementing the provisions of this Decision, the following terms and expressions shall have the meanings assigned thereto, unless the context otherwise requires:

Country:	The United Arab Emirates.
Ministry:	The Ministry of Economy.
Minister:	The Minister of Economy.
Decree-Law:	Federal Decree-Law No. (20) of 2018 on Anti-Money Laundering and Combating the Financing of Terrorism and Financing Illegal Organisations, and its amendments.
Implementing Regulations:	Cabinet Decision No. (10) of 2019 on the Implementing Regulation of Federal Decree-Law No. (20) of 2018 on Anti-Money Laundering and Combating the Financing of Terrorism and Financing Illegal Organisations, and its amendments.
Registrar:	Authority having competence to supervise the trade names register for the various types of establishments registered in the country.
Concerned Entities:	The government authorities concerned with the implementation of any provision of the Decree-Law and the Implementing Regulation.
Beneficial Owner:	The natural person who ultimately owns or exercises ultimate control over a legal person, directly or through a chain of ownership or control, or other indirect means, as well as the natural person on whose behalf transactions are conducted or who exercises ultimate effective control over a legal person or a legal arrangement, specified in accordance with the text of Article (5) of the aforementioned Cabinet Decision No. (109) of 2023.
Nominee Board Director:	Any natural person acting in accordance with the directions, instructions or will of another person. Nominee Board Director is

	officially appointed or holds a position in the legal person and usually represents shareholders, members or any other relevant entity.
Senior Management:	Decision-making authority of the legal person.
Beneficial Owners' Record:	Special register for the actual beneficiaries of the legal person, that includes all their data.
Register of Partners or Shareholders:	Special register for the partners or the shareholders of the legal person, that includes all their data.
Written Warning:	An official announcement sent to the legal person or its representative through legitimately available means.

## **Article 2**

### **Scope of Application**

The provisions hereof shall apply to legal persons licensed or registered in the country, including non-financial free zones, in violation of the provisions of aforementioned Cabinet Resolution No. (109) of 2023.

## **Article 3**

### **Administrative Penalties**

1. Without prejudice to any penalty or procedure stipulated in the Decree-Law and other relevant legislation, the Registrar may impose the administrative penalties applicable against the violators of the provisions of Cabinet Resolution No. (109) of 2023, according to the violations and penalties in the schedule attached hereto.
2. In addition to the fine prescribed for violations committed for the third time as mentioned in the schedule attached hereto, the Registrar may suspend the commercial licence and close the commercial store of the violating legal person, provided that the suspension can be released once the said legal person pays the fine prescribed for the violation and corrects it by fulfilling the requirements which were violated.

## **Article 4**

### **Amendment of Fines**

The Cabinet shall have the authority to make any amendments, addition, deletion or change, to the fines mentioned herein.

## **Article 5**

### **Federal Government and Local Governments shares of the Administrative Penalty Proceeds**

The Cabinet shall issue a resolution determining the percentages for sharing the administrative penalty proceeds contained herein between federal government and local governments, based on the proposal of the Minister of Finance and after coordination with the Minister and the Registrar.

## **Article 6**

### **Final Provisions**

1. Fines stipulated herein shall be collected by the means determined by Ministry of Finance.
2. For the purposes of collecting the administrative fines mentioned herein, a part of the day shall be considered a full day and a part of the month shall be considered a full month.

## **Article 7**

### **Executive Decisions**

The Minister shall, in coordination with the registrar, issue the directives and procedures necessary to implement the provisions hereof.

## **Article 8**

### **Abrogation**

Cabinet Decision No. (53) of 2021 on the Administrative Penalties to be Imposed on the Violators of Cabinet Decision No. (58) of 2020 Concerning the Regulation of Beneficial Ownership Procedures shall be abrogated, and so shall any provision deemed contrary to or inconsistent with the provisions of this Decision.

## **Article 9**

### **Publication and Enforcement of the Decision**

This Resolution shall be published in the official gazette and shall be effective the following date of its publication.
